Applicants must complete this form in full and provide all relevant supporting documentation to enable a comprehensive assessment. Nexus Institute will not issue a Confirmation of Enrolment (CoE) until all required information has been received, assessed, and verified in accordance with ESOS legislative requirements and institutional admissions policies.
